	Cal AIM ECM – Carissa gave a high-level overview of Cal-AIM programs. See attached presentation slides for details.
 Carissa Avalos Program Manager Special Program 	• Enhanced Care Management (ECM) – there are 10 Population of focus approved by DHCS.
	New Population of Focus (PoF) for ECM Justice Involved (JI)— effective January 1, 2024, MCPs are responsible for administering ECM for JI PoF once an individual is released from incarceration. Anthem is working with county, correctional facilities, and other MCPs to prepare for this PoF, including data sharing.
	 Birth Equity – effective January 1, 2024, aimed to improve prenatal and postpartum care and closing disparities in access to care.
	 Child and Youth – effective July 1, 2023, for children and youth with highest social and clinical risk enrolled in Medi-Cal Managed Care Plans (MCPs).
	 Outreach for perinatal clients and birthing pathways – Anthem conducts proactive identification using encounter data and algorithm that identifies members with for birthing and perinatal populations. Also encouraging providers and community partners to make the referrals.
	Community Support (CS) – a menu of services, at the option of a managed care plan and a member, can substitute for covered Medi-Cal services as cost-effective



alternatives. Anthem is live for all 14 approved DHCS services and continues to accept LOIs (Letter of Interest) for those providers who are interested in participating the network.

- Who can refer? Anthem practices "No wrong door approach"
 - Member self-referrals
 - ECM/CS provider referrals
 - Community providers

Referral process

- Complete the population of focus screening check list.
- Complete the exclusionary screening checklist.
- Submit completed referral form to Anthem.
- Community Health Worker skilled and trained health educators who work directly with individuals who may have difficulty understanding and/or interacting with providers due to cultural and/or language variers. They serve and is a link between health, social services, and the community to facilitate access to services and improve quality and cultural competence of service delivered. Questions:

How to become a contracted CHW provider?

- 1. Complete and submit the Letter of Interest form to Anthem.
- 2. Anthem will send application upon receipt of the LOI.
- 3. Anthem will conduct certification review to ensure that CHW provider(s) meets all the qualifications, trainings, or certification.
- 4. Organization (i.e., FQHCs, CBOs, etc.) will need to sponsor CHW.
- Once CHW is added to the network, then CHW can bill for services rendered.

Anthem has received LOIs (Letter of Interests) and continuing to extend invitations to CHWs who are interested in contracting.

Does Anthem have any grants to support for people who want to get certified as a CHW?

Response: Anthem offers Incentive Payment Program (IPP) which will help bring on CHW which can include training.

Doula – DCHS added as a covered benefit as of January 1, 2023. See Cal_AIM presentation slide for details of covered benefit.

Doula services provided for individuals during and following pregnancy, including childbirth and the postpartum period. Doulas support the pregnant individual through perinatal period, with the goal of improving outcomes for birthing parents and infants.

Anthem received has received LOIs (Letter of Interest) and continuing to extend invitations to CHWs who are interested in contracting.

	 Can Anthem provide a listing of contracted Doula providers? Response: See attached provider list. Can member do a self-referral? Response: Member can self-refer or providers, WIC, providers, etc. Use the Recommendation Form. Are license providers aware of the Doula benefit? Are they making referral for this service as they have their prenatal visits? Response: Anthem has been conducting education around Doula and sharing this new benefit to providers, county partners, CBOs, and other stakeholders. Anthem encourage community partners to share information about this new benefit.
