

1                                   **AMENDMENT NO. 1 TO MEMORANDUM OF UNDERSTANDING**

2                   This Amendment No. 1 to Memorandum of Understanding (MOU) is dated  
3 04/02/2025 and is between Mono County Behavioral Health as the Mental Health  
4 Plan, herein after referred to as “County” or “Mental Health Plan” (“MHP”), and each provider  
5 listed in Revised Exhibit A “Medi-Cal Managed Care Plans List, hereinafter referred to as  
6 “Contractor” (collectively the “parties”).

7   **Recitals**

8                   A. On September 12, 2024, the County and the Contractor entered into MOU with  
9 Managed Care Plans (MCPs) Blue Cross of California Partnership Plan, Inc. (Anthem) and  
10 Health Net Community Solutions, Inc., to ensure that Medi-Cal beneficiaries enrolled in MCP  
11 who are served by MHP (“Members”) are able to access and/or receive mental health services  
12 and substance use disorder services in a coordinated manner from MCP and MHP.

13                  B. On January 9, 2025, the Department of Health Care Services informed the  
14 County of the need to include the titles of the designated persons in the MOU.

15                  C. The parties now desire to amend the MOU include the titles of  
16 the MCP designees and the titles of the County Designated Staff assigned to this MOU.

17                  The parties therefore agree as follows:

18                  1. All references to “Exhibit A” shall be deemed references to “Revised Exhibit A”, which is  
19 attached and incorporated by this reference. All references to “Exhibit B” shall be deemed  
20 references to “Revised Exhibit B”, which is attached and incorporated by this reference. That the  
21 existing MOU, section four (4), paragraph b of the MOU starting on page three (3) with the word  
22 “Oversight”, and ending on page three (3) with the word “must” be deleted and the following  
23 inserted in its place:

24                  **“Oversight Responsibility.** The Director, Program Management of Anthem and the  
25 Program Manager of Health Net Community Solutions, Inc, listed on “Revised Exhibit A” of  
26 this MOU are responsible for overseeing MCP’s compliance with this MOU. The MCP  
27 Responsible Persons must:”

1       2. That the existing MOU, section five (5), paragraph b of the MOU, starting on page four  
2 (4), with the word "Oversight" and ending on page four (4) with the word "must" be deleted and  
3 the following inserted in its place:

4       **"Oversight Responsibility.** The Mono County Behavioral Health Quality Assurance  
5 Coordinator listed on "Revised Exhibit B" of this MOU is responsible for overseeing MHP's  
6 compliance with this MOU. The MHP Responsible Person serves, or may designate a  
7 person to serve as the designated MHP Liaison, the point of contact and liaison with MCP.  
8 The MHP Liaison is listed on "Revised Exhibit B" of this MOU. The MHP Liaison may be the  
9 same person as the MHP Responsible Person. The MHP must notify MCP of changes to  
10 the MHP liaison as soon as reasonably practical but no later than the date of change. The  
11 MHP responsible person must:"

12       3. When both parties have signed this Amendment No. 1, the MOU and this Amendment  
13 No. 1 together constitute the Agreement.

14       4. The Contractor represents and warrants to the County that:

- 15       a. The Contractor is duly authorized and empowered to sign and perform its obligations  
16       under this Amendment.
- 17       b. The individual signing this Amendment on behalf of the Contractor is duly authorized  
18       to do so and his or her signature on this Amendment legally binds the Contractor to  
19       the terms of this Amendment.

20       5. The parties agree that this Amendment may be executed by electronic signature as  
21 provided in this section.

- 22       a. An "electronic signature" means any symbol or process intended by an individual  
23       signing this Amendment to represent their signature, including but not limited to (1) a  
24       digital signature; (2) a faxed version of an original handwritten signature; or (3) an  
25       electronically scanned and transmitted (for example by PDF document) version of an  
26       original handwritten signature.
- 27       b. Each electronic signature affixed or attached to this Amendment (1) is deemed  
28       equivalent to a valid original handwritten signature of the person signing this

1 Amendment for all purposes, including but not limited to evidentiary proof in any  
2 administrative or judicial proceeding, and (2) has the same force and effect as the  
3 valid original handwritten signature of that person.

4 c. The provisions of this section satisfy the requirements of Civil Code section 1633.5,  
5 subdivision (b), in the Uniform Electronic Transaction Act (Civil Code, Division 3, Part  
6 2, Title 2.5, beginning with section 1633.1).

7 d. Each party using a digital signature represents that it has undertaken and satisfied  
8 the requirements of Government Code section 16.5, subdivision (a), paragraphs (1)  
9 through (5), and agrees that each other party may rely upon that representation.

10 e. This Amendment is not conditioned upon the parties conducting the transactions  
11 under it by electronic means and either party may sign this Amendment with an  
12 original handwritten signature.

13 6. This Amendment may be signed in counterparts, each of which is an original, and all of  
14 which together constitute this Amendment.


15 7. The MOU as amended by this Amendment No. 1 is ratified and continued. All provisions  
16 of the Agreement and not amended by this Amendment No. 1 remain in full force and effect.
