- We need that all set up so that there's a smooth transition plan happening

- Nurse Family Partnership and CalWORKS visitation program quick update:
- We just want to thank everybody for their continued partnership, and we do have an abundance of referrals now, so there is a bit of a wait list, but we're making it through the list.
- Clients are being outreached to while they are on the waiting list, and we are triaging them based on medical acuity and they're PSYCHOLOGICAL factors as appropriate.
- And for those who are a little bit more stable, providing information on other
  prenatal referral pathways throughout the county and our partnering case
  management programs and the community.
- We are bracing ourselves for the governors updated budget that will soon be passed.
- Governor Newsom has on the table a general cut to all CalWORKS home visitation programs of \$47.1 million on the table.
- So as the governor and at the state level, they are navigating to see what that will look like for the next fiscal year and for our home visitation program as we do see a lot of our CalWORKS, pregnant and parenting clients out in the community and we hope to continue with maximum service for the next fiscal year.

### MCAH:

- We are on the final stage of finalizing the responses for the state's deliverables.
- We've finished all the in-person meetings, hybrid meetings and we've tallied all the prioritization surveys, discussions, scheme forms, and interviews that we have gathered so far throughout a year process.
- We just need to send out the final form.
- The state only requires us to submit our answers through a MS form and that's it.
- It will go through the state.
- All 61 local health jurisdictions will go through all the answers and then they will bring it back to us in 2025.
- Besides the local needs assessment, this also in involves the children and youth with special health care needs, capacity system assessment.
- This is a 2 IN 1 state requirement.

- We have been doing a lot of events for the month of May.
- Most of our events have been around Black Heritage Month and around maternal health map black maternal Health week.
- We've had a lot going on working with our Supervisor and Board of Supervisors for commendations.
- Doing a lot of presentations out in the community on weekends.
- Juneteenth event coming up. Both programs, perinatal equity and black infant health, will be participating and having booths out there for Juneteenth.
- We're getting an uptick in clients since we had our perinatal equity initiative conference that we had last in the beginning of May.

- With that Conference, a lot of the providers and the doctors that we communicate with through Valley, Stanford, and O'Connor, and every other hospital in our community.
- Supervisor Elenburg, who is the champion for BIH, gave out awards to those hospitals who are really trying to bring clients into the BIH program, and it is really made a fantastic difference.
- We're having a hard time trying to make sure we get to everybody on time. But we're getting we're getting there.
- We have a little bit more staff now and we're able to serve a lot of women.
- We just had our event at the Rose Garden for Mother's Day.
- We're going to hear more about the government budget and how that relates to our programs, PEI & Black Infant Health, at our conference that is coming up at the end of June.
- We will be having that Conference up in Sacramento June 27th through the 29th.
- We're having our Mother's Day event on May 30th, called Mother's Appreciation Day.
- We have that open for our clients who are pregnant and parenting right now.
- We're collaborating with the library to have the story time for moms and babies.
- Closed event. Not open to the public.

### SIDS -

- Sudden Infant Death Syndrome is led by our public Health Nurse 3, Stephanie Ponce.
- The nurses are aware of that policy and how to provide grief, resources, and support during the difficult time for these families.

### WIC-

- We have a new WIC director, and her name is Vivian Wong. Began April 15, 2024. A lot going on with WIC, we don't have an OMC. With the hiring freeze, hopefully we can move forward with that as soon as possible.
- We have a few vacancies that we urgently wanted to hire as far as contract go, we do have a deadline to meet for contract management amendment that is still the end of this month.
- Federal funds have finally been approved. But they will take at least two years to finalize because they need to work with different vendors, more is coming.

### Foster Care -

- First Five Home Visitation Program: this is our program where we have a team of public health nurses who provide home visitation for children and families involved in juvenile justice, foster care dependency.
- Unfortunately, our partnership with first five Santa Clara County will be winding down as of the end of June.
- Our funding will unfortunately be ending at that time, and so we're working
  collaboratively right now with our Department of Family and Children Services to
  start a new program called Milestones Home Visiting Program, serving the same
  population, but we're really looking at how we can enhance the collaboration
  between DFCS and public health to provide more enhanced experience for the
  clients for this particular population.
- We're hoping to launch that as of July 1st and we're working hard to get that going.
- Overall, public health in general, is working and looking at how the county budget is going to affect some of the work that we do.
- There's going to be some decision making at the board level to decide how monies will be affecting programs.
- We should know by the beginning of June what that will look like for our programs.

# TCM MOU:

Retroactive as of January 1st, 2024, we are no longer participating in targeted case management. So we'll not be engaging in a TCM MOU and we've already informed DHCS.

As these individuals transition to full scope Medi-Cal, California has prioritized two goals: 1) Maintain PCP assignment to the maximum extent possible; and 2) Support and strengthen traditional county health providers who treat a high volume of uninsured and Medi-Cal patients. Working on establishing a stand-alone BAA with SCC HSS. SFTP Site is set up. Test files have successfully been exchanged. Data will be exchanged once BAA is established.
