Coordination of Care & Screening and Transition of Care Tool Check-In (Continued)	 All FIT Contracted Providers and CAPs Clinics accept walk-ins. ✓ No call is necessary to get connected to Mental Health Services. ✓ If they are connected to Managed Care Plans, the transition of Care Tool is utilized. Minimum qualifications for Foster Family agencies and STRTPs to contract with us to provide MH Services was just released a few weeks ago. ✓ STRTPs already provide MH Services to clients in their homes but they have temporary shelter care homes where they don't provide MH Services. ✓ The new contracts will allow them to hire their own staff so that families can be serviced by one agency instead of working with multiple agencies to get MH services covered. ✓ Please see the attached link for more information on Minimum Qualifications for Foster Family Intervention Resources Services and Treatment – FFIRST.
