IV.	 Local Health Department Updates- Haley shared the following updates: General – The LHD is getting an electronic health record. 7 individuals have received training. They will begin to bill for services soon. Janet will shared the steps that need to be followed in order to bill Anthem for public health services. Halley also mentioned that she would like to have some training on the Community Services, Community Health Worker benefit. Health Net and Anthem to handoff to respective CalAlM team members. Immunization -due to funding cuts trying to maintain baseline services with the schools through Vaccines for Children. The challenge is providing vaccines to individuals with commercial insurance, as they are unable to get the vaccines through a physician. Haley asked if there was anyway the managed care plans could provide the vaccine if they had member information in advance. COVID Equity Funding was eliminated and this was used to support immunization staff. Sexually Transmitted Disease (STD) – HIV testing is up and running. Staff have been trained and supplies received. They still have the DIS grant through the CDC which provides Take Home Kits online. The county is building up its communicable disease response case investigations. Tuberculosis (TB) – Minimal grant, funding quickly dwindles when they get one case. Maternal Child and Adolescent Health (MCAH) – The focus is on outreach. Home visiting funding is being built up. Currently have 3 home visitors 	County Team

	 trained. They are training parents to be teachers to increase enrollment and outreach. California Children Services (CCS) – Focus is on Case Management, Occupational Therapy, Physical Therapy and Referrals. The State provides oversite responsibility and monitoring. Trisha with Health Net asked for a contact that she can share member information with. Justin said she can send to him and also Courtney. Childhood Lead Poisoning Prevention Branch (CLPPB) – Blood Level Screening – Not participating, received information for funding next year but decided not to pursue due to the workload requirement. The County defers to the state for investigation.
