To accommodate the number of clients they are serving, CVRC has hired 26 new service coordinators. They're looking to hire 25 more Services Coordinators by November of 2024. In addition, CVRC has 2 program Managers positions open. Once filed they've have a total of 50 Program Managers.  Currently the staff to client ratio is 1:70; to be in compliance, they need to be 1:62.  CVRC has also implemented a new SC lead staff role.	CVRC Team
