	CalViva Health/Health Net – Anthem Blue Cross – Kaiser Permanente MOU: • Kings County BH–MHP MOU executed on August 27, 2024. • Kings County BH SUD-DMC MOU was signed by KP on 9/3/24, by Anthem on 9/5/24, by CalViva Health on 9/6/24 and Health Net signed on 9/9/24. MOU was approved/signed on 9/24/2024 by County BOS. • On 11/12/24 DHCS requested corrections of the SUD DMC MOU: Items needing revision: • Inclusion of effective date in the MOU [page 2, paragraph 1]. • Inclusion of the title of the MCP Responsible Person in the Oversight Responsibility section of the MOU [page 4, Sec. 4(b)]. • Inclusion of the title of the DMC Responsible Person in the Oversight Responsibility section of the MOU [page 4, Sec. 5(b)]. Grant Zweifel mentioned that DHCS reached out and told them they needed to do an amendment on the MH-MHP MOU because the state is concerned about the fact that they didn't have the effective date stated in the contract. This is due to the signature dates were all different, so it was not clear what that date would be, and DHCS wanted them to make sure they added the date to the MOU. Grant added that they complained to the state about it, and the state came back and said "never mind" this will be good enough. Ana Lopez stated that they received the same correction on the SUD-DMC MOU from DHCS and made the same complaint. Ana sent DHCS another request to reconsider the need for correction that the corrections are restatement of what is already indicated. Ana added that they did reach back to DHCS, and they indicated a follow-up with them in January 2025. The team and MCPs debated whether to amend or create a new MOU, with concerns about effective dates and compliance. Kaiser suggested a new MOU instead of an amendment. Voiding the first MOU and doing a new one to avoid compliance issues and adding explicit language to the new MOU to ensure the last signature date is the effective date.	MCPs
